The driving style and the aggressiveness of the driver during the out lap are of utmost importance to minimise the stress generated over the carcass of the tyres. We recommend the drivers always avoid aggressive kerb usage, particularly until the tyres have reached an internal pressure close to their optimum running pressure.
